Conservation Administrator Ed Hoopes, and Administrative Assistant Kim Cavanaugh were also present.

**I. REQUESTS FOR DETERMINATION**

- A. Lynne Minard.** Installation of fencing and buffer demarcation at 64 Bay Street, Osterville as shown on Assessor's Map 117 Parcel 031. **DA-26010**

The applicant was represented by Arlene Wilson of A.M. Wilson Associates.

Issues discussed:

- The revised plan is dated February 2, 2026.
- The stone demarcation will mark the 50' buffer.
- The smaller fences will not be dug into the ground. They will be approximately 4" off the ground.
- Administrator Ed Hoopes agrees with the delineation.

A motion was made to approve the project as a negative determination with the revised plan dated February 2, 2026.

## **II. NOTICES OF INTENT**

- A. Town of Barnstable Department of Public Works** – Concrete repairs to the deck curbs, sidewalks, counterweight and bearing supports, steel removal and repairs throughout the bridge, replacement of operating machinery and electrical systems with associated appurtenances and minor associated clearing at the Oyster Harbors bridge on Bridge Street, Osterville.

The applicant was represented by Griffin Beaudoin of Town of Barnstable DPW. and Alli Lov of STV, Inc.

Issues discussed:

- The DEP number has not been issued. A continuance will be needed.
- A question was asked how will the river be protected during construction.
- They will be meeting with the contractor regarding specifics on each element of the project. They are required by contract to prevent anything from falling into the water.
- A special condition should be added that a work protocol will be submitted to Conservation staff for approval.
- Any work that will affect the opening or closing of the bridge will be done during the off season.
- The work will begin next fall.
- Most of the repairs are being done under the bridge so there should be minimal effects on traffic.
- The repairs should last 15-20 years.
- A continuance was requested to Feb 10, 2026.
