BACKGROUND: The Hyannis Golf course provides food and beverage services to its golfers and the general public through a license agreement making the kitchen, lounge, outside deck, function room and snack bar available to a concessionaire. The base 3-year agreement was bid in a public procurement via a Request for Proposals (RFP) that resulted in an award to a local vendor. The term of the agreement as set forth in the RFP was for an initial 3-year term, with an option for the Town to extend for an additional 3 years, for a total term not-to-exceed 6 years.

Under General Laws c. 30B, § 12(b), the Town Manager may not award a contract for a term exceeding 3 years, including any renewal, extension, or option, without a majority vote of the Town Council.

ANALYSIS: The Town of Barnstable issued the RFP under General Laws c. 30B for these concession services to get the base award of 3 years in place to allow the awarded concessionaire to do preparatory work with plans to open for the 2026 golf season.

The potential of the longer term, with a viable operator, provides stability and consistency in providing food and beverage services to support the robust golfing operations at Hyannis Golf Course. The RFP required the submission of:

- A professional proposal meeting all of the requirements of the RFP,
- Documentation that the proposer has all licenses and permits required or could obtain those needed for the food and beverage operations at the location,
- Successful and similar experience,
- A track record of financial success,
- A business plan,

FINANCIAL IMPACT: The presence of food and beverage services is important to complete the golfing experience. The Concessionaire pays the Town a monthly fee to operate at this location, which is expected in year 1 to be \$24,000 per year plus 2% of annual gross sales over \$500,000. There is an escalator in the contract to the base amount due to the Town. Included in the contract is the requirement that the Concessionaire provide full food and beverage insurance coverage at their expense, naming the Town as an additional insured. This includes the liability associated with the serving of alcohol. In addition, they pay a substantial amount of the utilities associated with operation of the building.

At the end of the initial three-year term, Town staff will make a recommendation to the Town Manager whether to exercise the three-year option period. Because the issuance of an RFP and the preparation of a proposal in response to the RFP is a costly undertaking for both parties, having the ability to extend the agreement for an

additional three years provides important flexibility to the Town, assuming that the awarded concessionaire is thriving at the location.

BACKGROUND: The Commonwealth's Community Compact IT Grant Program is a competitive program focused on driving innovation and transformation at the local level via investments in technology.

The Town has been awarded a grant under this program in the amount of \$100,000 to make digital accessibility improvements and to assist with efforts to achieve compliance with the Americans with Disabilities Act (ADA) Title II Digital Accessibility Rule. This rule requires that municipal web sites and digital content meet specific accessibility standards by April 2027.

These grant funds will be used to purchase software tools and professional services to evaluate our digital content for accessibility problems, precisely identify and prioritize items that are non-compliant, and to assist with remediation of any issues found.

ANALYSIS: Aside from reaching compliance by April 2027, improving Digital Accessibility will have an impact on the community by increasing accessibility of the Town's digital resources. Barnstable has a significant aging population and an increasing reliance on digital content in the provision of services to our community. Achieving Digital Accessibility compliance will ensure that our digital content and services are accessible to everyone in the community.

FISCAL IMPACT: While there is no funding match required by this grant, the Town will likely need to continue paying for ADA compliance software tools beyond the initial grant period. Once compliance is achieved, it will be important to continue monitoring new digital content with these tools so that we remain compliant into the future.

BACKGROUND: The Town of Barnstable has been awarded \$150,000 in funding from the Massachusetts Executive Office of Housing and Livable Communities (HLC) to support the creation and implementation of a First-Time Homebuyer Assistance Program.

This program is intended to expand access to homeownership for low- and moderate-income households by providing financial assistance for the purchase of a primary residence within the Town of Barnstable. Funds will be structured as deferred payment, zero-interest second mortgage loans, ensuring long-term affordability.

ANALYSIS: The program is designed to assist approximately three (3) income-eligible households, with up to \$48,000 in assistance per household, along with administrative support.

Eligible uses of funds include:

- Down payment assistance
- Gap/bridge financing
- Necessary health and safety repairs required for home purchase

Applicants must meet defined eligibility criteria, including:

- First-time homebuyer status
- Household income at or below 80% of Area Median Income (AMI)
- Asset limitations
- Completion of homebuyer education

The program includes long-term safeguards to ensure public benefit, including:

- Minimum 15-year affordability restriction
- Principal residency requirement
- Loan repayment if the home is sold within the first 15 years of ownership. Repayment Schedule: Establish sliding scale for repayment (e.g., 100% if sold within first 5 years; 6-10 years repay at 60% at closing; 11-15 years 30% at closing; over 15 years zero repay).
- Funds must be returned to EOHLC.

The program will be administered by a third-party program administrator under the oversight of the Town's Planning & Development Department, ensuring compliance with all state requirements.

FISCAL IMPACT: The total grant award is \$150,000, which will fund direct assistance to eligible households and program administration.

- Approximately \$144,000 allocated for direct assistance
- Approximately \$6,000 allocated for administrative costs

All funds must be expended by June 30, 2026, in accordance with EOHLIC requirements. There is no impact on the Town's general fund, as the program is fully grant-funded. Any repaid funds will be returned in accordance with state guidelines and project scope.

BACKGROUND: The Commonwealth of Massachusetts Department of Environmental Protection Bureau of Waste Site Cleanup administers a technical assistance grant to assist municipalities with funding for outside expert advice and education and outreach related to assessment and cleanup activities at disposal sites in their communities. The Barnstable County Fire & Rescue Training Academy PFAS cleanup site is located within the Town of Barnstable. The Town applied for and was awarded a \$20,000 grant to assist with interpretation and presentation of cleanup activities at the Barnstable County Fire & Rescue Training Academy.

ANALYSIS: The Barnstable County is responsible for cleanup of the disposal site and disseminating information to the Town. It is required that they provide reports, scopes, and monitoring data associated with the disposal site cleanup actions. Acceptance of this grant will allow the Town to retain a Licensed Site Professional to assist the Town and the community in reviewing new documentation related to the Barnstable County Fire & Rescue Training Academy and provide them with an ongoing assessment of the adequacy of response actions and recommendations for any additional actions to protect public health, welfare, and the environment.

FISCAL IMPACT: This grant is a reimbursement grant in the amount of \$20,000. The Town must expend and request reimbursement of the costs. All costs associated with this grant must be expended prior to June 30, 2027.
